Award

We are pleased to announce the 2016 Dorsey & Whitney Diversity Fellowship program. This is the eleventh year that Dorsey has offered the Diversity Fellowship.

Dorsey's Minneapolis and Seattle offices will each select a first-year law student to receive the Dorsey Diversity Fellowship and work as a 2016 summer associate. Recipients will receive \$7,500 toward law school tuition and expenses for the 2016-2017 school year. Recipients who return to Dorsey for the summer following their second year of law school will receive an additional \$7,500 for the 2017-2018 school year, and an additional \$5,000 if they join the firm as an associate.

First-year law students may apply to the Minneapolis and Seattle offices on or shortly after December 1, 2015 and no later than 11:59 p.m. (CT) on January 18, 2016.

Eligibility

All law students of diverse backgrounds who attend an ABA-accredited school are eligible to apply, subject to the class year requirement as noted above. Successful applicants will have a demonstrated record of academic achievement and a commitment to promoting diversity in the legal community.
